



David Little, CFA Senior Manager Research Analyst david.little@morningstar.com Morningstar's quarterly KiwiSaver Survey is designed to help New Zealand investors assess the past performance and other key characteristics of their KiwiSaver superannuation options. The accompanying tables show KiwiSaver fund returns for the three months and one, three, five, and 10 years to September 30, 2023.

Key Takeaways

- KiwiSaver assets decreased, owing entirely to market movements, ending the quarter at NZD 96 billion, down around NZD 2 billion for the quarter.

Market Commentary

Markets continue to embrace higher-for-longer interest rates by pushing out expectations of a reversal of interest-rate policy in 2024. Locally, in the near term, upside risks from migration and fiscal policy could add to domestic demand and slow the expected pace of disinflation. This is somewhat countered by downside risks to global growth. Given the material lift in interest rates globally of late, and lags between monetary policy and the real economy, late-cycle risks to earnings and credit have risen. These risks are being accentuated by geostrategic and geopolitical shifts. Some have been positive for U.S. growth, such as reshoring at the expense of China. However, recent Middle East tension and higher oil prices add complexity to the required disinflation process. Equity markets sold off in the September quarter as prospects for interest rates set in, which also saw a sharp repricing in bond markets, with the correlation between the two turning positive again in a similar fashion to 2022. With the sticky inflation dynamic more embedded in interest-rate expectations, the outlook particularly for risk-based assets is becoming more challenging.

The Reserve Bank of New Zealand retained its official cash rate at 5.5% in October. Policy settings were noted as "constraining economic activity and reducing inflationary pressures as required," with the growth outlook "subdued." While the policy stance was unchanged, it was noted that "interest rates may need to remain at a restrictive level for a more sustained period of time." Longer-term interest rates have followed offshore direction, rising around 50 basis points, with the New Zealand 10-year bond rising to 5.5%. The New Zealand dollar has been broadly stable over the past month at just below NZD 0.59 against the U.S. dollar at the time of writing, and the 17-currency trade-weighted basket is just below 70 (index). Risk sentiment, central bank policy settings, and China have been key drivers.

The New Zealand equity market weakened over the September quarter, with the S&P/NZX 50 (Total Return) Index returning negative 5.2%. However, it still recorded a gain of 2.1% over the one-year period.



Fund Manager Results

Almost all multisector KiwiSaver funds produced negative returns over the September quarter. The average multisector category returns ranged from negative 1% for the conservative category to negative 3.1% for the aggressive category. As for default funds, Super Life fared the best during the quarter, losing the least. Over longer periods, Quay Street, Milford, and Generate all continue to perform well across the categories in most periods.

It is most appropriate to evaluate the performance of a KiwiSaver scheme by studying its long-term returns. Over 10 years, the aggressive category average has given investors an annualized return of 8.0%, followed by growth (7.6%), balanced (6.1%), moderate (4.3%), and conservative (3.9%).

Furthermore, the Morningstar Global Sustainability Rating was added to the survey in the previous quarter, displaying funds with 4- and 5-globe ratings received. The Sustainability Rating is designed to support investors in evaluating the relative environmental, social, and governance risks within portfolios.

Market Share

KiwiSaver assets in the Morningstar database decreased during the September quarter to NZD 96.2 billion. ANZ leads the market share with more than NZD 18.8 billion. Fisher is in second position, with a market share of 15.5% knocking ASB back to third by acquiring KiwiWealth. BT dropped down to the fourth spot ahead of Milford, which debuted in the top five. The five largest KiwiSaver providers account for approximately 68% of assets and fees within our database.

About This Survey

This survey groups KiwiSaver options according to their mix of income and growth assets, or "asset allocation." This is one of the most important decisions to make when saving for retirement. The term "income assets" refers to cash and fixed-interest securities that generally produce stable and reliable returns but offer little opportunity for long-term capital growth. Returns from "growth assets" such as property and shares can be volatile—as recent market conditions have demonstrated—but over time have shown a greater capacity for increasing in value. The mixture of income and growth assets is the major determinant of potential return and volatility.

Investors may notice differences between the returns published in this survey and those they see elsewhere. There are several possible reasons for this. First, the returns published here are after fees but before tax. Second, we take the associated tax credit into consideration when calculating and publishing these returns, while some fund managers base their published performance figures on month-end unit prices only.


