KiwiSaver Survey September Quarter 2021

Subdued returns for Multisector KiwiSaver funds following strong June results, KiwiSaver assets continue to grow and climb over NZ\$87 billion.

Morningstar's quarterly KiwiSaver Survey is designed to help New Zealand investors assess the past performance and other key characteristics of their KiwiSaver superannuation options. The accompanying tables show KiwiSaver fund returns for the three months, one, three, five and ten years to 30 September 2021.

Market Commentary

International shares reached new highs in August and early September before reversing most of the quarter's gains in the second half of September, as economic momentum slowed in the US and China. At the end of the September quarter, international shares edged into positive territory with a return of 1.3% in NZD. The U.S. market notched up a small positive return for the quarter with the S&P/500 up 0.6%. On a sector level, performance was more mixed than the previous two quarters as six sectors produced positive returns. Financials were the standout performer, healthcare also performed well, bolstered by strength in pharmaceutical stocks following more COVID-19 vaccine mandates and booster shot approvals. At the other end of the spectrum, industrials and the materials sectors lagged, both sectors finished with negative returns for the third quarter. Domestically, strong gains by names such as Mainfreight and Ryman Healthcare helped the S&P / NZX 50 Index record a gain of 4.9% over the quarter. Despite a halt to domestic activity in Australia as states were subjected to extended lockdowns, the S&P/ASX 200 Index rose 1.7% over the September quarter. Investor sentiment was propped up by a strong earnings season with a number of companies reporting strong earnings upgrades. All but one sector was positive over the quarter, energy was the standout sector with a return of 9.3%, while the materials sector was the weakest, down 9.9% as iron ore prices experienced a sharp decline.

New Zealand REITs were positive for the quarter, the S&P/NZX All Real Estate Index was up 3.2%, while A-REITs also posted a positive return of 4.2% in AUD terms, outperforming the broader market. The Bloomberg Barclays Global Aggregate Index in U.S. dollars was marginally up 0.1% over the September quarter, while the S&P/NZX NZ Government Bond Index fell 1.2%, and the S&P/NZX Investment-grade Corporate Bond Index was also down 1.2%.

Fund Manager Results

KiwiSaver funds generally reflected the subdued underlying market conditions experienced over the September quarter with the bulk of multisector funds experiencing a return of less than 1%. Funds with larger exposures to domestic growth assets and lower exposures to domestic fixed interest generally outperformed over the three-month period. The average multisector category returns ranged from 0.2% for the Conservative category to 0.9% for the Growth category. Top performers over the quarter against their peer group includes **Pathfinder Conservative** 1.6% (Multisector Conservative), **Milford Moderate** 1.2% (Multisector Moderate), **Pathfinder Balanced** 2.3% (Multisector Balanced), **Pathfinder Growth** 2.9% (Multisector Growth), and **Mercer High Growth** 2.1% (Multisector Aggressive).

It is most appropriate to evaluate performance of a KiwiSaver scheme by studying its long-term returns. Over 10 years, the Aggressive category average has given investors an annualised return of 11.4%, followed by Growth (11.2%), Balanced (9.2%), Moderate (6.7%), and Conservative (5.9%).

Market Share

KiwiSaver assets on the Morningstar database sit at more than NZ\$87.3 billion as at 30 September 2021 up from NZ\$76.3 billion at 31 December 2020. ANZ leads the market share with more than NZ\$19.0 billion. ASB is in second position, with a market

share of 16.6%. Westpac holds third spot ahead of Fisher Funds, while AMP sits in fifth spot. The six largest KiwiSaver providers account for approximately 72% of assets on our database.

About This Survey

This survey groups KiwiSaver options according to their mix of income and growth assets, or "asset allocation". This is one of the most important decisions to make when saving for retirement. The term "income assets" refers to cash and fixed interest securities that generally produce stable and reliable returns but offer little opportunity for long-term capital growth. Returns from "growth assets" such as property and shares will be erratic – as recent market volatility has demonstrated – but over time have shown greater capacity for increasing in value. The mixture of income and growth assets is the major determinant of potential return and volatility.

Investors may notice differences between the returns published in this survey and those they see elsewhere. There are several possible reasons for this. First, the returns published here are after fees but before tax. Second, we take the associated tax credit into consideration when calculating and publishing these returns, while some fund managers base their published performance figures on month-end unit prices only.

Morningstar has adopted its global policy for dollar-based fees, to the JUNO funds in this instance. We have chosen a conservative KiwiSaver balance, of \$10k, and applied the JUNO fee for that balance (\$60) to get 0.60%. We have deducted that from the return we generate using its unit prices, which are pre fee. This percentage impact to each member is likely to be higher, or lower, than this figure.
